On the occasion of “**International Custom Duty Day**” Department of Commerce has organized the online Guest Lecture on the topic “**Essentials of Custom Duty**” on **Wednesday, 26<sup>th</sup> Jan 2022 at 3.00 p.m.** This lecture was organized for B.Com students.


**Mr. Somnath Kolhe**, Assistant Professor, Department of Commerce, Vinayakrao Patil Mahavidyalaya, Vaijapur, addressed the audience on Essentials of Custom Duty. The lecture began at 3.00 p.m. During his speech, Customs duty in India is defined under the Customs Act, 1962 and enables the government to levy duty on exports and imports, prohibit export and import of goods, procedures for importing/exporting and offenses, penalties, etc. All matters related to customs duty fall under the Central Board of Excise & Customs (CBEC). The CBEC, in turn, is a division of the Department of Revenue of the Ministry of Finance. CBEC formulates policies that concern the collection or levying of customs duties, customs duty evasion, smuggling prevention, and administrative decisions related to customs formations.

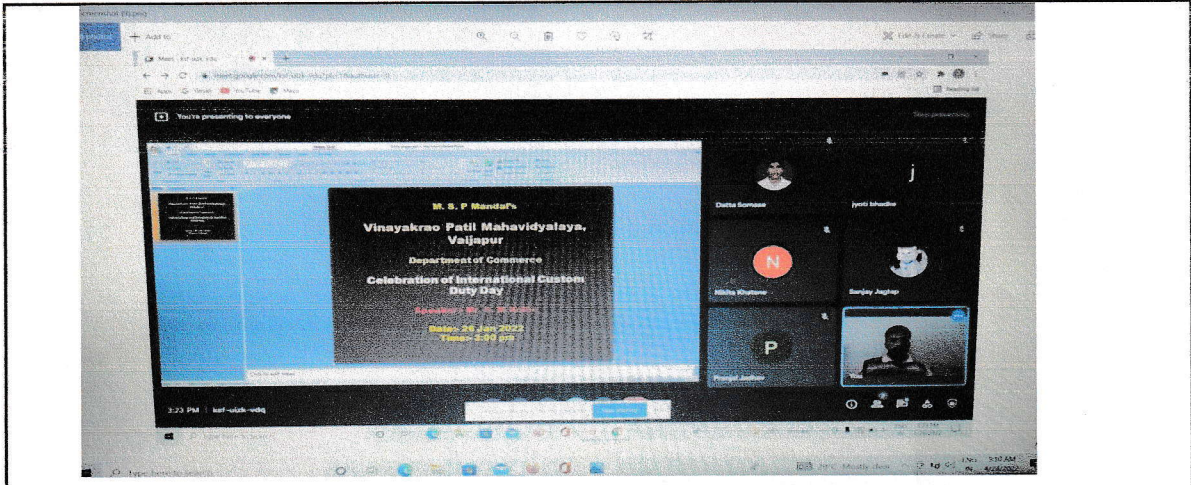
CBEC has various divisions that take care of the fieldwork including Commissionerate of Customs, Customs, Customs (preventive and Central Excise Zones, Central Revenues Control Laboratory and Directorates, etc. CBEC also oversees proper tax administration for foreign and inland travel.
